USER AGREEMENT

- 1. Term.** The term of this agreement is one year and becomes effective upon the City of Nelson's acceptance. At the time of this agreement, the City of Nelson will allow existing Bike Cage users in good standing to renew this agreement annually. The City of Nelson reserves the right to change this policy. It will be your responsibility to ensure that you renew before the end of the term of this agreement.
- 2. Fee.** The user will be required to pay a deposit equal to the price of the fob. Upon cancellation you will be required to return the fob in good condition to receive your deposit.
- 3. Permitted Use of Bike Cage.** You may store one bicycle (including electric power-assisted bicycles of normal bicycle size) in the Bike Cage. You may not store gasoline-powered bicycles in the Bike Cage. You may not use the Bike Cage for any other purpose or storage of anything other than your bicycle and items related to your bicycle commute. You may not lease or rent Bike Cage use to someone else. You cannot share your fob with anyone else for their use. Bicycles can be stored in the Bike Cage up to 48 hours at a time; it is not for long-term bicycle parking. Bicycles left in a Bike Cage for more than 48 hours may be removed by The City of Nelson. You must ensure that the Bike Cage is locked upon exit.
- 4. Use on a Space Available Basis.** Your right to use the Bike Cage is on a first-come first-serve basis. The City of Nelson does not guarantee that space will be available at all times of the day.
- 5. Damages.** You will be responsible for the cost of Bike Cage repair needed because of the misuse or abuse of the Bike Cage.
- 6. Notices.** All notices to be provided to you under this agreement may be made by either regular or certified mail or email. You are responsible for notifying The City of Nelson of a change of street or email address.
- 7. Liability.** While the Bike Cage provides an additional level of security over our regular bicycle racks, they are not guaranteed to prevent theft or damage. Use of the Bike Cage is at your own risk. The City of Nelson is not responsible for any loss or damage to your bicycle, and/or to any other items, left in the Bike Cage. You are responsible for securing your bicycle and its components.
