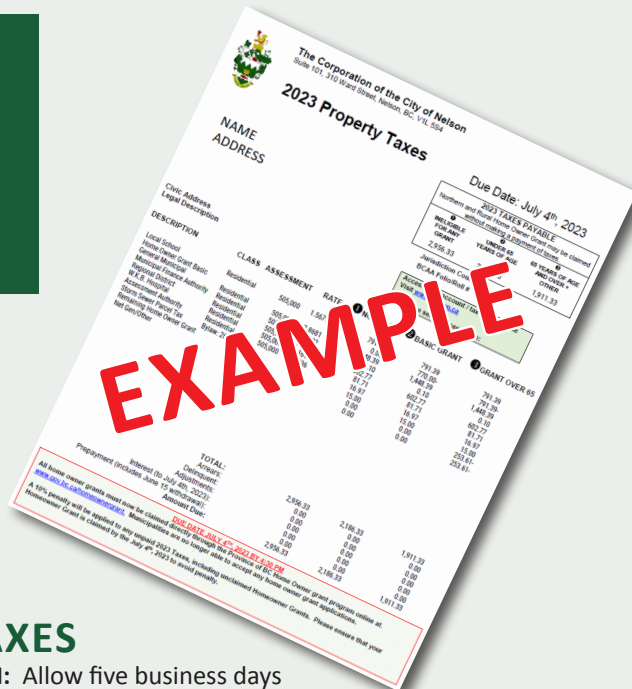

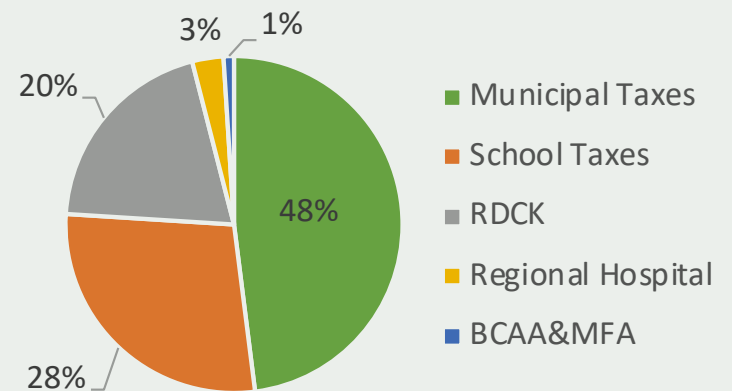

THE BIGGER PICTURE

Your tax invoice breakdown – by Agency

The City of Nelson also collects taxes for a number of important services and organizations we all rely on, not just for the municipality itself. Those include Kootenay Lake District #8, the Regional District of Central Kootenay (RDCK), the Regional Hospital Board, the BC Assessment Authority (BCAA) and the Province's Municipal Finance Authority (MFA).



PAYMENT OF TAXES

- **Pay at your Bank or ATM:** Allow five business days prior to deadline if paying at the bank or ATM.
- **Pay by Mail to City Hall:** Post marks are not accepted as proof of date of payment. We accept CDN postdated cheques.
- **24 Hour Drop Off:** Payments can be deposited in the drop box located beside the front entrance at City Hall before July 4th at 4:30PM. We accept CDN postdated cheques.
- **Pay Online:** Visit www.nelson.ca/propertytaxbills. Credit cards payments subject to a fee.
- **Pay at City Hall:** 101 – 310 Ward Street, Nelson, BC V1L 5S4.

PROVINCIAL HOME OWNER GRANT

Claim your provincial home owner grant before July 4th, 2023!

- Civic Address
- BC Jurisdiction Code – 219
- BCAA Folio/Roll Number
- Social Insurance Number

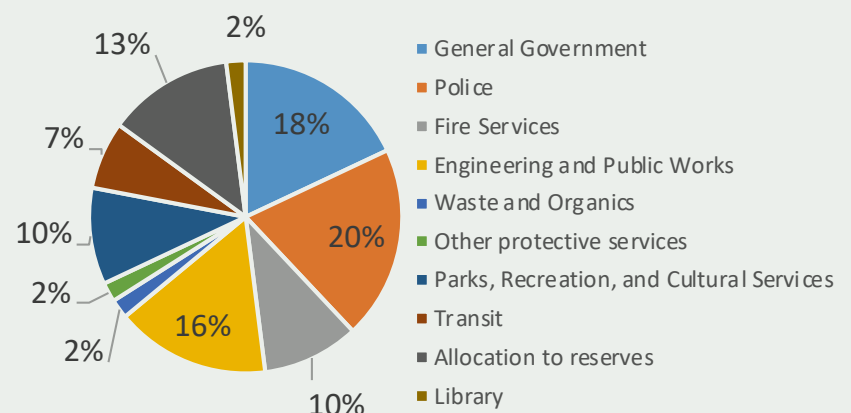
